This is to certify that the amended articles of incorporation of the

(Amending Articles IV by extending the term of its existence and VII thereof)

copy annexed, adopted on September 28, 2012 by majority vote of the Board of Directors and by the vote of the stockholders owning or representing at least two-thirds of the outstanding capital stock and certified under oath by the Secretary and a majority of the Board of Directors of the corporation was approved by the Commission on this date pursuant to the provision of Section 16 of the Corporation Code of the Philippines, Batas Pambansa Blg. 68, approved on May 1, 1980 and copies thereof are filed with the Commission.

Unless this corporation obtains or already has obtained the appropriate Secondary License from this Commission, this Certificate does not authorize it to undertake business activities requiring a Secondary License from this Commission such as, but not limited to acting as: broker or dealer in securities, government securities eligible dealer (GSED), investment adviser of an investment company, close-end or open-end investment company, investment house, transfer agent, commodity/financial futures exchange/broker/merchant, financing company, pre-need plan issuer, general agent in pre-need plans and time shares/club shares/ membership certificates issuers or selling agents thereof. Neither does Certificate constitute as permit to undertake activities for which other government agencies require a license or permit.

AMENDED

ARTICLES OF INCORPORATION

OF

WESTERN GUARANTY CORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, all of legal age, citizens and residents of the Republic of the Philippines, have this day voluntarily associated ourselves together for the purpose of amending a corporation under the laws of the Philippines.

AND WE HEREBY CERTIFY:

FIRST: That the name of the said corporation shall be -

"WESTERN GUARANTY CORPORATION"

SECOND: That the purposes for which the said corporation is formed are:

PRIMARY PURPOSE

- 1) To insure houses, tenements, merchandise, and all other property and effects, real or personal, against loss or damage by fire, storm, earthquake shock, fire resulting from earthquake, accident or otherwise, and to carry on the ordinary business of fire insurance in all of the aforesaid branches. To rebuild, repair, replace or reinstate houses, buildings, machinery and every other description of property which may be insured by the company to carry on any kind of business necessary or expedient for any such purpose;
- 2) To insure against every description of marine risk, which may legally be undertaken, relating to the perils of the sea, fire, war reprisal and all other risk of a like nature incidental to the seas, ships, vessels and water craft of all descriptions, and also the freight, goods, cargo and all property whatsoever in or on board the same, so far as the same may be effected or made according to law;
- 3) To grant either in the Philippines or abroad, policies or other instruments of insurance against, or insuring compensation or payment in case of death or injury to health shipwreck or other perils of the land, sea or air, or any other accident or misadventure, or violence during any journey or voyage by land or water or air, or during any other limited supply medicine and surgical aid and treatment or any other assistance of accident or harm to any person or the family and household of any to any person dwelling or staying in the house of such person insured;
- 4) To reinsure all or any risk of the company and to undertake all kinds of reinsurance and counterinsurance connected with the business of any other company;
 - 5) To guarantee the fidelity of persons hiding places of public or private trust;
- 6) To guarantee the performance of contracts, agreements, undertakings, obligations, promises of duties of all kinds other than insurance policies;
- 7) To guarantee the performance of insurance contracts where surety bonds are accepted for such purposes;
- 8) To execute and to guarantee bonds and undertakings of all kinds required or permitted to be taken in any or all actions, proceedings, negotiations, exportations, or other transactions or operations, either by private individuals, or by heads of departments, courts, judges, officers, boards, or bodies, whether executive, legislative or indicial:

- To guarantee and to indemnify merchants, traders and those engaged in business of giving credit, from loss or damages by reasons of giving and extending such credit to other customers or persons dealing with them;
- 10) To indemnify against loss by burglary, theft, forgery, embezzlement or any or more of such happenings;
 - 11) To insure glass against breakage;
- 12) To guarantee and to indemnify the owners and users of steam boilers and pipes, or fly wheels, engines of all kinds or of machinery against explosions or other accidents and against loss or damage to life or properly resulting therefrom and against liability unto third persons by any of said causes; and to make inspections of and to issue certificates of inspection upon such boilers, pipes fly wheels, engines and machinery;
- 13) Generally to execute, sign and carry out fidelity bonds and surety undertakings of every nature and kind usual in the business of fidelity and surety companies or permitted by law unto such companies;
 - 14) To land on such terms as may seem expedient, subject to the requirements of law;
- 15) To purchase or otherwise acquire and undertake all or any part of the business, property and liabilities of any person or company carrying on any business which this company is authorized to carry on, or possess property suitable for the purpose of this company;
- 16) To acquire by purchase, subscription, or otherwise and to invest in, hold, sell or otherwise dispose of the stocks or bonds or any interest in either or any obligation or evidence of indebtedness of any corporation, or corporations, and while the owner of such stocks, bonds, or interests, exercise all the rights, powers and privileges of ownership, including the right to vote thereon or consent in respect thereof for any and all purposes;
- 17) To purchase or otherwise acquire, sell, lease, convey, mo tgage, encumber, and otherwise deal with any property or interest therein, real or personal, as may be permitted by law and as may be reasonably necessary to enable it to carry out the purposes for which the corporation is created as may now or hereafter be permitted by law;
- 18) To procure the company to be registered or recognized or be permitted or allowed to carry on its business or any branch or branches thereof in any State, Territory possession of the United States and/or in any foreign country or place; and in carrying on its business to do any and all acts and things, and exercise any and all powers which a natural person could do or exercise which now or hereafter may be authorized by law:
- 19) To do all or any of the above things in any place which the company may determine as principals, agents, contractors, trustee or otherwise, and by or through trustees, agents or otherwise and either alone or in conjunction with others;
- 20) To do and perform any and all of the acts and things and lo exercise all of the general powers conferred by law, upon corporations similarly organized and usually and ordinarily incidental to companies of like nature and kind;
- . 21) And in general, to engage in the business of insurance business for a consideration to indemnify any person, firm or corporation against loss, damage or liability arising from an unknown or contingent events, and to act as in any of their branches with the exception of life insurance.

THIRD: That the principal office of the Corporation is to be located and established in the City of Manila, Philippines. The Board of Directors may establish and maintain such branch officers within or without the country as it may deem convenient or necessary for the business of the corporation;

FOURTH: That the term for which said Corporation is to exist is another FIFTY (50) YEARS from August 31, 2014. (As amended September 28, 2012)
